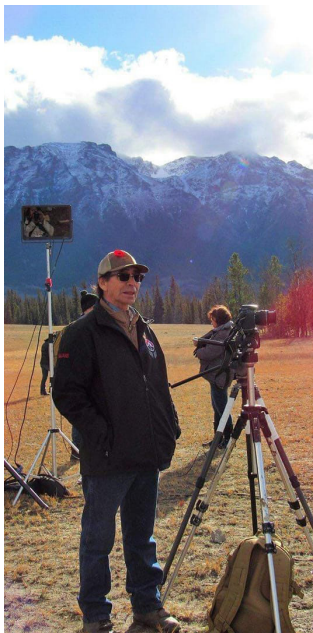

We, the T̓silhqot'in, or People of the River, are made of up six communities: ʔEsdilagh, Tl'esqox, Tl'etinqox-t'in, T̓sideldel, Xenigwet'in and Yune̓sit'in. Our ancestral nen (land) includes the d̓zelh (mountains) and the ʔElhdaqox (Fraser River).



As T̓silhqot'in, we have occupied our ancestral *nen* since time immemorial. We have never ceded or surrendered our rights or our sacred responsibilities to our *nen*. Our future is as firmly tied to the *nen* as our past. We will continue to sustain our communities from our *nen* and resources, we will forge a strong future for our next generations and we will hold true to our identity as T̓silhqot'in people.

Guiding Principle

The T̓silhqot̓in Nation will consider culturally and ecologically conscious development of mineral resources in the T̓silhqot̓in traditional territory, provided the ecological and cultural values of the T̓silhqot̓in are respected and there are significant long-term social and economic benefits for T̓silhqot̓in communities. Relationships between the T̓silhqot̓in and mining and exploration companies must be built on a foundation of respect for T̓silhqot̓in values, rights and governance, and real partnerships built on trust and recognition that the land comes before money. The T̓silhqot̓in Mining Policy is without prejudice to our Aboriginal rights and title.



Purpose

The T̓silhqot̓in Nation has created this law to:

1. Communicate T̓silhqot̓in values about our *nen*;
2. Provide greater certainty for mining and exploration companies; and
3. Ensure meaningful T̓silhqot̓in participation in mining and exploration.



Dechen Ts'edíhtán Néndíd Beghád Hágwétát'ílh

Tsìlhqot'in nídlín néndúwh jíd déchen nídenitan: Nexwenén tsi jedetalhdež ʔéyen nén gán néndíd xánélhyax sútsél ghajaghétátínlh hínk'an núlh gatš'i chuh sútsél ghajaghíztán séʔágwétát'ílh. Nexwedení ʔech'an gúts'ílhʔín séx ʔéjedetat'íes ʔegúh hínk'ed Tsìlhqot'in nídlín néxwets'éen séʔágúnt'ih. Tsi jedetalhdež ʔéyen Tsìlhqot'in yádí jílhʔín ʔégú ts'ídaneš jíd ʔélhéhl ʔánájétat'ín. Tsìlhqot'in gubagughížʔán, guberíghs hágwélésnih, xúgúlh'tí déchen jedílh'tán téʔagúnt'ih ʔéyed, tsi jedetalhdež ʔéyen yádí jegúlhʔín ʔégú ts'ídaneš jíd ʔélhéhl ʔánájétat'ín. Hínk'an Tsìlhqot'in nén ʔeyed séneya ch'á jégwedílh'tí jégwétálhtsax. Néndíd tsi ts'edelhdež gwá dechen ts'edílh'tán ʔalyágh ʔéyi Tsìlhqot'in nén jéguntén hínk'an xúgúlh'tí gúbagughížʔán ʔeyed lha gwets'ah tásdláx hánt'ih (Lha bíd néxwerights ʔídetezaghádínsh).

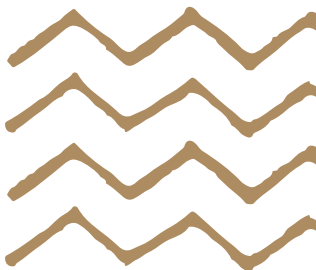
Objectives



- **MINIMIZE NEGATIVE IMPACTS** of mining and exploration to protect the environment and the continuity of the T̓silhqot̓in way of life.
- **MAXIMIZE BENEFITS TO T̓silhqot̓in COMMUNITIES** to the greatest extent possible.
- **BUILD RELATIONSHIPS** between the T̓silhqot̓in and mining and exploration companies.
- **CLARIFY DECISION-MAKING** responsibilities and processes of the T̓silhqot̓in.

1. Minimize Negative Impacts



We will:

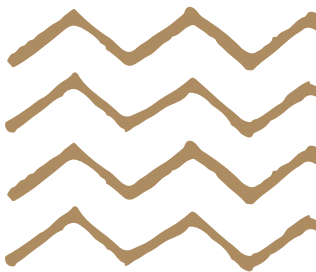
- a. Protect our critical environmental, cultural and spiritual sites and areas of the T̓silhqot̓'in traditional territory to remain as they have always been.
 - b. Ensure mining and exploration projects are designed, managed and monitored to protect the environment, minimize disturbance and include T̓silhqot̓'in-led cumulative impact and cultural impact assessments.
 - c. Ensure that the *nen* is returned to a state acceptable to the T̓silhqot̓'in.
 - d. Protect our relationship with the *nen* and sustain our culture.

Actions

2. Maximize Benefits to T̂silhqot'in Communities

We will:

- a. Increase the capacity in training of T̂silhqot'in members to meaningfully participate in jobs, training, and contracts associated with mining and exploration.
- b. Consider partnership and ownership opportunities with mining and exploration companies.
- c. Ensure T̂silhqot'in priority with regards to securing meaningful jobs, training, procurement and contracts with mining and exploration companies.
- d. Promote awareness of T̂silhqot'in culture, social circumstances, and spiritual beliefs.
- e. Require exploration agreements (for mineral exploration companies) and impact benefit agreements (for mining companies) prior to approval of any exploration or mining project.
- f. Require resource revenue from mining projects.
- g. Promote diverse sustainable economies that do not rely on non-renewable resource extraction.

We will:

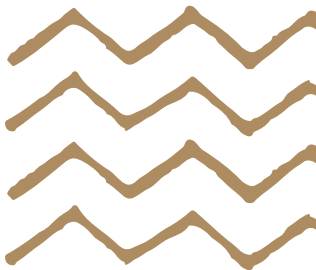
- a. Expect open and honest dialogue with all mining and exploration companies in the T̓silhqot̓in traditional territory.
 - b. Implement a clear, certain process whereby mining and exploration companies can meaningfully engage with the T̓silhqot̓in.
 - c. Educate mining and exploration companies about T̓silhqot̓in rights & way of life.
 - d. Contribute traditional and scientific knowledge to discussions regarding mining and exploration projects.

Actions

4. Clarifying Decision Making



We will:

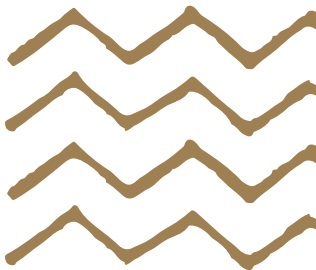
- a. Exercise and communicate Tsilhqot'in decision-making responsibility regarding mining, exploration and reclamation projects.
- b. Implement streamlined and stable engagement and decision-making processes regarding mining and exploration projects.
- c. Require exploration agreements (for mineral exploration companies) and impact benefit agreements (for mining companies) as the basis for granting the free, prior and informed consent of the Tsilhqot'in for projects.
